Volunteer Agreement and Release of Liability

Reading with Rover is a Washington non-profit corporation that is a community-based literacy program volunteering in schools, bookstores and libraries of the Puget Sound area of Washington. In this Agreement, "Reading with Rover" means the corporation, its officers, directors, employees and agents. Reading with Rover will make all the necessary arrangements to provide you with an opportunity to participate in the Reading with Rover program.

In consideration for my participation in the Reading with Rover program, my signature below indicates that I have read, understand and agree as follows:

1. I agree to volunteer my time and talents to the Reading with Rover program. I acknowledge that my activities with Reading with Rover are voluntary and that I have not received compensation for my services. I acknowledge receipt of a copy of Reading with Rover's guidelines and policies and agree to abide by such guidelines and policies at all times.
2. I understand that the Reading with Rover name and logo is the sole property of Reading with Rover, and I will not use the name or logo in any fashion without the written approval of Reading with Rover. If I am given confidential information of Reading with Rover, I will treat that information with confidence and will not disclose it to anyone.
3. I understand and agree that if I fail to comply with the terms of this Agreement or am otherwise unable to meet the Reading with Rover volunteer program requirements, I will be terminated from the program. I further understand that I may at any time with or without cause be removed from my position as volunteer at the sole discretion of Reading with Rover.
4. I understand that Reading with Rover assumes no legal liability for the actions of me or my pet in our roles as volunteers. I will release, indemnify and hold harmless Reading with Rover, its officers, directors, agents and their heirs and assigns from any and all claims, damages and liability arising from or related to my activities as a Reading with Rover volunteer.
7. I understand that while performing volunteering activities in the Reading with Rover program, I am insured by Reading with Rover's commercial general liability insurance policy for certain losses both caused and/or suffered by me or my animal. I also understand that the following activities are not covered by such general liability insurance and if loss is suffered as a result of the following activities, I will be responsible to the extent not covered by insurance:
 - My pet or I cause a loss to other Reading with Rover volunteers.
 - My pet or I cause a loss that is in excess of Reading with Rover's commercial general liability insurance.
 - My pet or I intentionally cause a loss or act outside of the scope of the Reading with Rover volunteer activities or outside of the scope of Reading with Rover policies and guidelines.

I REPRESENT THAT I AM OVER EIGHTEEN YEARS OF AGE AND ACKNOWLEDGE THAT I HAVE READ THIS AGREEMENT CAREFULLY AND I FULLY UNDERSTAND ITS CONTENTS AND IMPLICATIONS. I AM AWARE THAT THIS IS A WAIVER AND RELEASE OF LIABILITY AND INDEMNITY AGREEMENT, AND THAT IT IS BINDING AND ENFORCEABLE BY LAW.
